2. Please be advised that, all shipping agents and port users who want to bring the ship into the port water limit for lay up purpose shall request permission from Johor Port Authority.

3. Under **Section 3 (2)(y) Port Authorities Act 1963 (Amendment 1992)** which set out the functions of port authority are:

'to provide facilities for laying-up vessel and prescribe fees thereof'

4. Lay up application procedures are as follows:
- i. Obtain the lay up application form from Johor Port Authority, fill up and complete the form. Application form, term and condition can be obtain from Marine Unit Johor Port Authority or download at www.lpj.gov.my.
 - ii. Refer to Johor Port Berhad (JPB) / Port of Tanjung Pelepas (PTP) for confirmation of lay up position (Longitude / Latitude).
 - iii. Submit the completed application form to Johor Port Authority.

- iv. Lay up application shall be approved by Johor Port Authority provided that it comply with term and condition.
- v. Refer to Marine Department Southern Region for crew manning and safety requirement of the ship.

5. This notice will come into effect from **01 MAY 2010**. Attached herewith is lay up application form, term and condition that need to be complied for the lay up purposes.
