**OPENING TIME FOR IMPORT/EXPORT LADEN CONTAINERS DURING THE FESTIVE SEASON**

Reference is made to the above matter.

As an effort to assist our customers in meeting the Government Regulation on the road restriction for heavy vehicles carrying non-essential goods during Raya Festival (17<sup>th</sup> & 18<sup>th</sup> July 2015) as well as limited capacity facing by the hauliers during the long holidays, we are pleased to announce our assistance to our valued customers as follows:-

i) Opening Time for Export Laden Containers.

Opening time for export (laden) containers for vessel arriving from 17<sup>th</sup> July 2015 @ 0001 hrs to 23<sup>rd</sup> July 2015 @ 2359 hrs, is on 12<sup>th</sup> July 2015 @ 0001 hrs. The said containers shall be given a Free Storage Period from 12<sup>th</sup> July 2015 @ 0001 hrs till 23<sup>rd</sup> July 2015 @ 2359 hrs.

ii) Storage Period for Import Laden Containers.

Free Storage Period for import laden containers discharged from vessels into the terminal from 17<sup>th</sup> July 2015 @ 0001 hrs to 18<sup>th</sup> July 2015 @ 2359 hrs, shall remain at five (5) days, calculated from 19<sup>th</sup> July 2015 @ 0001 hrs.

Kindly be informed that the extension of the free storage period as per above applies only to the calculation of container store rent and auto relocation charges. The electricity and monitoring charges for refrigerated containers, AND demurrage charges charged by the Containers Operators/ Shipping Lines, shall be charged as per Johor Port Berhad's ("JPB") Container Tariff/ Liners' Demurrage Tariff. Consignees/ Forwarding agents are advised to apply individually to respective Shipping Lines if any exemption of demurrage is required.

Please also take note that containers containing dangerous/ hazardous goods and instructed by the JPB's Port Safety Department or the Governing Authority to be delivered/ loaded direct shall not be included in the above extension of opening time and free storage period.
